

**Petition for Waiver of Sidewalks

The undersigned, being all the owners of property on Battles Court, request the Council of the City of Chardon to waive the requirement for construction of sidewalks on Battles Court.


The undersigned owners acknowledge that the waiver will not be granted unless all of the property owners agree and the Chief of Police and Municipal Engineer determine that less than 200 motor vehicles a day travel on the street and pedestrian safety are not significantly reduced by the elimination of sidewalks.

If the Petition is approved, each property owner is responsible for the removal of the sidewalks in front of their property, restoration of the grade and seeding within 120 days of approval by the Council.

Should all of the property owners on Battles Court in the future petition the City to permit the installation of sidewalks, the property owners will be responsible for the entire construction cost of the sidewalks, in compliance with the Codified Ordinances and municipal specifications in effect at that time, either by direct payment or special assessment added to the owner's real estate taxes.
