- 1) No alcoholic beverages.
- 2) No horses, ATV's, snowmobiles, dirt bikes, or other motorized off-road vehicles.
- 3) No motorcycles, trucks, or cars are permitted beyond the designated parking areas.
- 4) No dogs are permitted unless they are confined on a leash and their excrement is removed promptly.
- 5) No open fires except in designated containers.
- 6) No garbage, bottles, or cans are to be left anywhere but in appropriate receptacles.
- 7) No climbing on fencing.
- 8) No skateboarding, skating, rollerblading, or other wheeled activity on sidewalk ramps.
- 9) No construction of jumps or ramps.
- 10) No cutting or trimming of trees or vegetation without the written consent of the Recreation Director.
